

NOTICE: BEGINNING JULY 29, 2024 PALM STREET - CONSTRUCTION ACTIVITIES

HOLLYWOOD NORTH BEACH UTILITIES UNDERGROUND CONVERSION

As construction activities progress, crews have been working diligently to install the proposed watermain and electrical infrastructure at Elm, Oak, Franklin, Douglas and Freedom Streets. Our watermain crew has however encountered some unknown conflicts on Franklin, and at the Intersection of Surf, that impacted the progression of work.

Whiting-Turner, the City and their Engineer of Record have investigated and established solutions to resolve these conflicts. Watermain crew has since resumed pipe installation on Franklin.

The Electrical crew on the other hand has completed the initial conduit installations on both Douglas and Freedom Streets, as well as the corresponding sections of A1A and Surf.

Future electrical phases at Douglas & Freedom are scheduled to resume in early to mid September.

Beginning **Monday, July 29, 2024**, the Electrical Crew will begin installing conduits from west to east along Palm Street then working their way north on Surf Road.

Work hours will be Monday through Friday between 7AM and 6PM.

Directional drilling technology will be utilized to efficiently minimize impacts to the neighborhood.

Access to each driveway will be established at the end of each workday. If vehicles are required during working hours, we ask that they be relocated before crews commence at 7AM.

TIMING

On Franklin through Balboa, underground utility crews (watermain) will work from east to west, with work zones segmented into three sections for each street, to facilitate access and egress.

Each section will be closed for approximately 30 days to facilitate installation, testing & inspections.

This schedule is subject to change based on inclement weather or other unforeseen circumstances.

Each subsequent street will be notified at least one week in advance of any construction activities.

TRAFFIC AND PARKING IMPACTS

- » Pedestrian Access to each residence / business will be maintained at all times
- » Please follow the posted signs and drive with caution, as workers will be present.
- » Construction equipment may be parked in the work-zone adjacent to your property, for extended periods of time, and therefore vehicular access to properties will be limited.
- » Temporary parking will be available on Perry Street to residents and businesses affected by the construction activities.

Registration is required through the project website listed below. Once registered, a Whiting-Turner staff member will issue a parking decal to hang from your vehicle's rear view mirror.
